U.S.-Indo-Pacific Standards and Technology Cooperation Program

The U.S. Trade and Development Agency is sponsoring this two-day workshop on the ASEAN region's electric vehicle sector transformation. Participants will engage with key U.S. and ASEAN regulators and industry experts to share technical advice and best practices for implementing policies that advance modern and innovative electric vehicle standards. **Participants may attend both days by registering once. The workshop will be held via Zoom.**

BACKGROUND

With increasing demand for electric vehicles (EVs), countries across the ASEAN region face a wide range of choices as they develop domestic regulations. Implementing international standards and best practices will help build strong EV ecosystems and enable a smooth energy transition.

As part of the U.S.-ASEAN Electric Vehicle Initiative, this workshop invites experts to share insights in domestic, regional, and international regulatory considerations, highlight industry experiences and economic opportunities, and promote standards harmonization.

The objectives of the workshop are to:

- Engage technical experts from ASEAN and the United States to share the latest developments in critical technologies and insights around standards and policies that support scaling of the EV industry
- Facilitate discussion among key policy-makers and industry experts on the benefits of international standards and conformance to support the development of cutting-edge and sustainable EV ecosystems
- Encourage alignment with international standards and best practices
- Foster cooperation between ASEAN stakeholders and industry partners and technology providers
